### 4. Legal Basis for Processing

We process your personal data under the following lawful bases:

Contractual necessity – to provide the veterinary services you request

Legal obligation – to comply with veterinary and financial regulations

Legitimate interests – to manage and improve our practice

Consent – where required (e.g., marketing communications)

### 5. Sharing Your Information

We may share your information with:

Veterinary laboratories and referral practices

Insurance companies (with your consent)



Payment processors

IT service providers

Regulatory bodies were required by law

We do not sell your personal data to third parties.

We retain clinical records in accordance with professional guidelines and legal requirements (typically a minimum of 6 years after the last treatment).
